The Chair (Mr Jim Maguire) opened the meeting and read out the apologies.

4. Presentation on 'Planet Youth Project' by Andy Ogle (Coordinator, North East Drug & Alcohol Taskforce) & Maureen McIntyre (Youth Officer, CMETB)

The Chair welcomed Andy Ogle and Maureen McIntyre to the meeting who were in attendance to provide a presentation on 'Introducing Planet Youth to Cavan/Monaghan'

The main points from the presentation were as follows:

- An inter-agency working group has recently been established whose aim it is to implement the Planet Youth Model to Cavan/Monaghan. Membership includes CYPSC, TUSLA and youth organisations.
- This is an Icelandic Model, that is a theoretically grounded, evidence-based approach to community adolescent substance use prevention that has grown out of collaboration between policy makers, behavioural scientists, field-based practitioners and community residents in Iceland.
- In the last two decades, the Planet Youth model has been instrumental in changing the culture around alcohol and drug use in Iceland and has also delivered very significant improvements in other health outcomes for young people.
- The five guiding principles of Planet Youth are: (1) primary prevention approach, (2) community action, (3) local, high-quality, accessible data and diagnostics, (4) unified team, (5) matches the scope of the solution to the scope of the problem.
- The aims for the Planet Youth in Cavan & Monaghan include:
 - Describe, appraise and analyse adolescents' health behaviour and wellbeing;
 - Identify protective and risk factors for health promotional activities;
 - Compare the health and wellbeing of adolescents with similar data from other countries/Irish counties within the Planet Youth collaboration;

 Guide evidence-based policy to promote the health and wellbeing of children and young people

5. Healthy Cavan – Healthy Ireland Community Mental Health Small Grant Scheme 2020

Angela Fitzpatrick provided an overview of grants awarded under the Healthy Ireland Community Mental Health Small Grant Scheme 2020. Angela reminded the Committee that approval had been given by the LCDC Committee at the June LCDC Meeting for the Healthy Cavan Sub-Group to evaluate and approve the grants, with the grants to be presented today for noting.

The Healthy Cavan Sub-group met on the 30th June 2020 to evaluate the applications received. As the total value of the applications received was €65,080 applications were evaluated by the Healthy Cavan Sub-group along the following assessment criteria: (A scoring system allowing maximum of 5 points under each of the assessment criteria was used: (maximum points 45))

- Alignment with Healthy Ireland Framework, Mental Health Priority Theme, other Government policies and plans (5 points)
- Adherence to programme requirements set out in point 4 (see above) of this document. (5 points)
- Focus on Target Groups(5 points)
- Quality of action and capacity to deliver outputs (5 points)
- Value for money (Are the costs included eligible and justifiable?) (5 points)
- Cross-sectoral engagement (5 points)
- New and Innovative Initiatives (5 points)
- Sustainability (5 points)
- Matching funds (5 points)
