### **Assan Bridge Rehabilitation and Junction Re-alignment, Assan, Ballyjamesduff County Cavan**

Notice is hereby given that Cavan County Council under the above legislation proposes to provide enhanced facilities for vehicular traffic by constructing a new bridge structure to the northeast side of the existing bridge and junction realignment at **Assan Bridge, Ballyjamesduff, County Cavan.**

The proposed development, which is the subject of this Part 8 procedure, will include the following:

- Provision of a new bridge structure (7.5m Clear Span and 8.5m overall width),
- Realignment of the L3545 (North of the existing Bridge) to connect directly to the L3005,
- Realignment of the river for 30m upstream of the bridge and installation of rock armour to protect the upstream and downstream banks,
- Rehabilitation works to the existing northeast face of the bridge and approaches,

An Appropriate Assessment Screening Report and an Architectural Heritage Impact Assessment Report of the proposed development have been completed and are available for inspection with this application.

Drawings and particulars of the proposed development will be **available for inspection or purchase** at a fee not exceeding the reasonable cost of making a copy, during normal office hours 9.00am to 1pm and 2pm to 5pm, Monday to Friday (excluding public holidays), at:

Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effect on the environment.
