Screening Determination for Strategic Environmental Assessment under SEA Directive 2001/42/EC as transposed into Irish law under Statutory Instrument (S.1.) 435/2004 European Communities (Environmental Assessment of Certain Plans and Programmes) Regulations 2004 (as amended)

For the Cavan County Council Noise Action Plan 2024-2028

Cavan County Council as the Competent Authority have undertaken screening of the Cavan County Council Noise Action Plan 2024-2028 (REF24/339TE: Strategic Environmental Assessment Screening Report and Determination for Cavan County Council (Draft) Noise Action Plan 2024 – 2028.) for Strategic Environmental Assessment (SEA) under Directive 2001/42/EC. The assessment for screening was carried out using criteria for determining the likely significance of effects as set out in Schedule 1 of 5.1. 435/2004 (as amended) (the 'SEA Regulations') and is set out in the SEA Screening Report (REF24/339TE) dated 17th July 2024 prepared by Traynor Environmental Ltd for the Cavan County Council Noise Action Plan 2024-2028.

Following assessment of the criteria and having regard to the nature of the plan and the potential for likely significant environmental effects from implementation of the plan, the Action Planning Authority (APA) has determined that the plan will not give rise to likely significant effects on the environment. This determination has been made following consideration of the information contained in the SEA Screening Report and the criteria set out in Schedule 1 to 5.1. 435/2004 (as amended). Furthermore, this determination is informed by consultation with the following statutory Environmental Authorities for SEA which was carried out alongside the statutory and public consultation of the Cavan County Council Noise Action Plan 2024-2028 from the 22nd of July 2024 to the 02nd of September 2024: the Environmental Protection Agency (EPA); the Minister for Housing, the Local Government and Heritage, Development Application Unit; Department of Environment, Climate and Communications; and Department of Agriculture, Food and the Marine; Department of Environment, Climate and Communications; Office of Public Works and adjoining local authorities. No further correspondence or feedback was received from the Statutory Environmental Authorities for SEA.

The principal reasons the Cavan County Council Noise Action Plan (NAP) 2024-2028 does not require SEA are as follows:

- Although the Cavan County Council NAP does set out a locational framework for noise, it is limited in terms of scale (i.e. it is strategic) and does not necessarily drive specific changes or actions, such as operating conditions or allocating resources that are at a sitespecific level. The Cavan County Council NAP does not directly specify detailed projects or activities that would necessitate Environmental Impact Assessment (EIA). Therefore, the degree to which the NAP drives other activities, is not significant in the context of the SEA Regulations.
- The Cavan County Council NAP has minimal influence on other plans and programs within the Agglomeration and primarily promotes environmental best practices and signposts existing mechanisms or environmental instruments that can be used to implement its aims, which in themselves may have been subject to environmental assessment.

- The Cavan County Council NAP seeks to manage the risk of additional members of the community being exposed to undesirable noise levels where they would have an adverse effect to health. In SEA terms it is not deemed that, when considered against other environmental conditions and problems, the Cavan County Council NAP would give rise to significant environmental effects on account of the high level and strategic nature of the mitigation set out in the NAP. This is also on account of the reliance upon existing or emerging plans and policies that are already or will be considered in respect of SEA.
- The Cavan County Council NAP covers an area which includes nationally and EU-level protected site regarding flora, fauna, species, and habitats. Measures included in the NAP are not likely to have specific geographic relevance because there is no Candidate Quiet Areas (CQA). Therefore, the NAP and its subsequent interventions will not lead to significant positive or negative noise effects on protected sites. It should also be noted that the factors to which ecologically designated sites such as SPA are protected does not necessarily correlate with changing noise levels. Therefore, in summary, the Cavan County Council NAP is not considered to have a significant effect upon recognised protected sites within the Agglomeration itself.
- The Cavan County Council NAP is not considered to have significant environmental transboundary effects, nor human health or environmental risks, and is unlikely to have cumulative effects, in the context of the SEA Regulations as it complies with other plans which have been assessed.

Determination

In making the determination, the information contained within the SEA Screening Report (REF24/339TE) has been taken into account and carefully considered. The Cavan County Council hereby confirm agreement that a Strategic Environmental Assessment (SEA) is <u>not</u> required for the Cavan County Council Noise Action Plan 2024-2028, in accordance with the European Union Directive 2001/42/EC (the SEA Directive) and Statutory Instrument No. 435 of 2004, European Communities (Environmental Assessment of Certain Plans and Programmes) Regulations 2004 (as amended).
